The Center for Development Policies IDEAS DePo (IDEAS DePo) is a non-profit association established on January 16, 2015 as a legacy organization arising from USAID's Investment Development and Export Advancement Support (IDEAS) Project, whose main objective is to provide reliable and competent expertise in the processes of design and implementation of economic and regulatory reforms in Macedonia and the region.

Its founders are professionals with extensive experience in designing and implementing economic and legal reforms in Macedonia, aimed at providing smooth transition from planned to market economy, creating sound business and regulatory environment, improving the efficiency and transparency of the policy-making process and strengthening the dialogue among all reform stakeholders.

IDEAS DePo draws its expertise and experience from several USAID development projects successfully implemented in Macedonia, that assisted the country accede to the World Trade Organization and comply with the complex WTO rules and principles; enhance regional trade integration and facilitation efforts; improve business environment and investment climate, including inspection services; increase export competitiveness of the private sector; create mechanisms for sustainable and inclusive public-private dialogue in context of economic reforms; and implement considerable number of e-government solutions for transparent and efficient public services.

Mission, Vision and Objectives

IDEAS DePo works on strengthening the capacity of the government and private sector institutions for implementation of the necessary reforms, establishing mechanisms for transparent and efficient governance and creating policies for intensive, sustainable and inclusive economic and social development.

- Introduction of the Third Pillar within the Pension system, based on voluntary contributions. The BEA Project conducted public debates, provided language to amend 66 legislative acts, and helped design the pillar's processes.

IDEAS DePo Projects

Booz Allen Hamilton Subcontract

In the early stages of its operations, during 2015, IDEAS DePo was subcontracted by Booz Allen Hamilton to implement a part of USAID's IDEAS Project program activities, in the area of Public Private Dialogue (PPD) and Inspection Reforms. The main beneficiary of the implemented activities and the support provided was the Government of Macedonia and the relevant institutions in the specified areas (among which: Ministry of Information Society and Administration, Inspections Council - IC, National Entrepreneurship and Competitiveness Council - NECC, State Market Inspectorate, State Labor Inspectorate, Chambers of Commerce and Business Associations, etc.).

The main achievements were:

Public Private Dialogue

- Support to the NECC (National Entrepreneurship and Competitiveness Council) Assistance to the NECC in operational issues; Education assistance for NECC staff and
 the NECC members; Support to NECC committees in performing their operational
 mandate.

 mechanism; campaign to improve public awareness about the ENER in the business and
 civil community; Improvement of knowledge of the public sector on ENER use.

Inspection Reforms

- Assisted in creation of methodologies and techniques for conducting inspection supervision – Developed an Inspection Methodology Manual for conducting inspection supervision, defining necessary technical instruments and sources of information and institutional linkage of relevant inspection authorities.
- Capacity Building of the Inspections Council (IC) and relevant Inspectorates Designed and conducted general and specific trainings and educational programs; Organized a study visit in Austria for exchange of knowledge and experience; Creation of a comprehensive web-site for IC, which encompasses all relevant data in regard to IC legal mandate, as well as all inspection authorities.

SEGURA Subcontracts

IDEAS DePo was also implementing two subcontractor agreements signed with SEGURA Consulting LLC, primary implementer of USAID's Regional Economic Growth (REG) Project. The first subcontractor agreement was in the area of Public Private Dialogue/Regulatory Impact Assessment (PPD/RIA) and was successfully implemented, while the second subcontractor agreement is ongoing and is focused on B-REDI Trade Facilitation in Macedonia, also in the frames of USAID's Regional Economic Growth (REG) Project.

Trade Facilitation

The overall objective of this initiative is to support trade facilitation reforms in the Republic of Macedonia in line with its national priorities and international commitments under the WTO Agreement on Trade Facilitation (WTO TFA) and the CEFTA Agreement.

More specifically, the initiative aims at:

Increasing the awareness of public and private sector institutions on the goals and main requirements of WTO TFA and strengthening their capacity for implementation of trade facilitation reforms in line with the Agreement.

Supporting the process of establishment and operation of mechanisms for enabling inclusive public-private dialogue and increasing transparency for more efficient and effective implementation of Macedonia's trade facilitation agenda.

Assisting key institutions with implementation of specific trade facilitation activities and measures.

The assistance is provided through a combination of activities designed in close coordination with beneficiary institutions from the public and the private sector, including but not limited to: National workshops and seminars treating specific trade facilitation subjects. Participation of representatives of Macedonia's government and private sector at regional events organized by the REG Project and its international partners with a goal of exchanging experiences and coordinating activities for the advancement of the regional trade facilitation agenda.

Technical assistance and advice regarding implementation of specific measures for facilitating and simplifying cross-border procedures.

Drafting of documents and procedures aimed at strengthening the mechanisms for dialogue and improving private sector access to relevant information.

Assistance activities are designed in a flexible manner, in close cooperation with the beneficiary institutions and wherever necessary, in coordination with other donors and international organizations active in the field of trade facilitation – the World Bank Group, CEFTA, WTO, WCO, UNECE and GIZ.

USAID Modernizing Inspection Authorities Project

In September 2016, IDEAS DePo signed a *Cooperative Agreement* with USAID for implementation of USAID's Modernizing Inspection Authorities Project. It has a four-year Project lifetime, until September 2020.

MIA Project objective

The overall objective of the Modernizing the Inspection Authorities Project is to introduce a modern, business friendly and predictable inspection system that will seek to achieve enhanced efficiency of inspection authorities, as well as voluntary compliance by implementing best practices and principles into the inspection process.

Component I - Streamlined Legal Framework of the Inspection System

The main objective of this Component is to achieve streamlined legal framework for governing the inspection system, an effort that is expected to produce multiple beneficial effects on the overall inspection system, by increasing the inspection authorities' efficiency, clearly defining their roles and responsibilities, reducing costs for conducting inspection supervision, setting up a clear system for compliance, decrease the burden for the private sector that is subject to supervision, introducing risk management principles in the process of inspection supervision and implementing standards and procedures that will enhance the inspection process.

Component 2 - Improved Knowledge of Inspectors in Specific Areas

The main objective of this Component is to strengthen inspector competencies, maintain and enhance their knowledge and skills, and increase their efficiency during conducting inspection supervision and implementing and enforcing legislation, through setting up regular and sustainable training programs and modalities that will advance the level of the overall inspection system.

Component 3 - Improved Effectiveness of the Inspection Bodies

The main objective of this Component is to improve the efficiency and transparency of the overall inspection system through introduction of new, modern technologies and methods that will facilitate inspection authorities' performance and contribute to better allocation of resources.

<u>European Bank for Reconstruction and Development (EBRD) – Project for Support to Improve the Effectiveness of Inspections in North Macedonia</u>

In November, 2019 IDEAS DePo signed a one-year **Contract** with EBRD for implementation of Support to Improve the Effectiveness of Inspections in North Macedonia – Assignment 1: Completing and Improving Regulatory Framework and Assignment 3: Capacity Building for Inspectors.

The overall objective of the project is to improve efficiency and coordination of the Inspectorates under the Inspection Council of North Macedonia, with the final goal of reducing burden and costs to businesses through finalizing the new legal framework for inspection supervision.
